It is a requirement that only those who meet the requirements below can enrol in this course. Those requirements are that a person must:

- Be eligible for VET Student Loans (if applying to use VET Student Loans).
- Hold a current Commercial Pilot Licence
- Hold a current Class 1 Medical and ASIC
- Spinning Flight Activity Endorsement

The below incidental fees are not covered by VET Student Loans and must be covered by the student:

- CASA testing fee. Approx \$900.00
- Text books— approx \$160.00

**Second and subsequent attempts for exams and flight tests, remedial ground and flight training are an additional student expense and not covered by Tuition Fees. They are charged at the standard aircraft/ instructor hourly rates published at Reception. Fees subject to change.**
