This VET course of study included only units of competency from the Aviation Training Package AVI08 (version 3.1). As this course is approved under the Higher Education Support Act 2003, eligible student's tuition fees may be deferred under the VET Student Loans scheme.

It is a requirement that only those who meet the requirements below can enrol in this course. Those requirements are that a person must:

- Be eligible for VET Student Loans (if applying to use VSL)
- Already hold a Commercial Licence (CPL)
- Hold a Class 1 medical and current ASIC
- At least 2 hours night flying including 1 hour solo.

The below services/materials are not included in the above Tuition Fees and are an addition cost to the student and not covered by VET Student Loans:

- Multi-Engine Endorsement Testing Officer fee - \$600.00
- Instrument Rating Testing Officer fee - \$900.00
- Materials – Bob Tait IREX Study Guide, DAPs East and West (or Jepps equivalent), AIP, 4 x ERC Low Charts, 4 x TAC Charts, PCA, ERSA – Approx \$470

Second and subsequent attempts for exams and flight tests, remedial ground and flight training are an additional student expense and not covered by Tuition Fees. They are charged at the standard aircraft/instructor hourly rates published at Reception. Fees subject to change.
