This VET course of study included only units of competency from the AVI Aviation Training Package. As this course is approved under the Higher Education Support Act 2003, eligible student's tuition fees may be deferred under the VET Student Loan scheme.

It is a requirement that only those who meet the requirements below enrol in this course. Those requirements are that a person must:

- Be eligible for VET Student Loans (if applying for VET Student Loans)
- Meet CASA Class 1 medical requirements and able to obtain an Aviation Security Identification card (ASIC)
- Be a minimum of 18 years of age for CPL Flight Test
- Meet VET Student Loans and Air Gold Coast entry requirements (see Course Guide for more details) including undertaking an approved [Pilot Aptitude Test](#) (cost \$275)

The below incidental fees are **not** covered by VET Student Loans and must be covered by the student:

- ASIC Card. \$257.00; Medical examination fee – refer to a CASA approved medical doctor - approx. \$600.00
- CASA Licence fees: RPL Licence \$50, PPL Licence Fee \$60; CPL Licence Fee \$80
- Text books, uniform and navigation equipment– approx. \$2000.00 (Approx. \$1,428 at induction, the remainder throughout the course)
- Headset – students choice. Price range from \$300 to \$1,800.
- A laptop or tablet is also strongly recommended for this course.

Total (approx. without headset): Approx. \$3,047.00

Second and subsequent attempts for exams and flight tests, remedial ground and flight training are an additional student expense and not covered by Tuition Fees. They are charged at the standard aircraft/ instructor hourly rates published at Reception. Fees subject to change.
