This VET course of study included only units of competency from the Aviation Training Package AVI08 (version 3.1). As this course is approved under the Higher Education Support Act 2003, eligible students tuition fees may be deferred under the VET Student Loans scheme.

It is a requirement that only those who meet the requirements below can enrol in this course.

Those requirements are that a person must:

- Be eligible for VET Student Loans (if applying to use VET Student Loans).
- Hold a current Commercial Pilot Licence
- Hold a current Class 1 Medical and ASIC
- Spinning Flight Activity Endorsement (can be completed during course)
- Complete pre-enrolment questionnaire and interview with Air Gold Coast
- Successfully pass CASA PMI Exam (complete prior to course commencement and after enrolment is confirmed)

The below incidental fees are **not** covered by VET Student Loans and must be covered by the student:

- CASA PMI Exam Fee. Approx \$170.00
- Text books– approx \$150.00 (ATC Flight Training Manual and ASA Flight Instructors Manual)
- A laptop or tablet is required for this course.

Second and subsequent attempts for exams and flight tests, remedial ground and flight training are an additional student expense and not covered by Tuition Fees. They are charged at the standard aircraft/ instructor hourly rates published at Reception. Fees subject to change.
